#### **CODE OF CONDUCT**

#### EAR PLUG WAIVER AND RELEASE

## Acknowledgement and Acceptance of Risk:

Such programs involve practicing, playing and hearing rock music at loud levels and can cause hearing damage or loss of hearing. I am aware that participation in these programs may entail known and unknown risks of injury to my hearing and my health. I expressly agree to accept and assume all responsibility and risk for potential injury or damage to my hearing or my health that arises from my participation in these programs. I freely elect to participate in Tomato's House Of Rock, LLC's programs despite such known and unknown risks. If I choose not to wear earplugs or other protective hearing devices when participating in such programs, my decision is purely voluntary. I am advised by Tomato's House Of Rock Music, LLC that I should wear protective hearing devices when participating in its programs because they may reduce the potential for hearing damage or loss of hearing from such activities.

#### Release:

In consideration of participating in Tomato's House Of Rock, LLC's programs, I, for myself or for any minors for which I am the parent or legal guardian do on behalf of myself or for such minors and on behalf of my or their heirs, personal representatives, or assigns, do hereby **release and hold harmless** Tomato's House Of Rock, LLC, its subsidiaries, affiliates and their respective members, principals, directors, officers, agents and employees from any and all liability for hearing damage or loss of hearing, and I hereby **waive** any lawsuit, claim or cause of action for damages arising from injury or damage to my hearing or loss of hearing as well as from any other personal injury resulting from my decision to participate in Tomato's House Of Rock, LLC's programs. This release and waiver shall apply regardless of whether I choose to wear, or choose not to wear earplugs or other protective hearing devices.

#### GENERAL WAIVER AND RELEASE

## ALCOHOL AND DRUG POLICY; WAIVER AND RELEASE

We hold the parents responsible for counseling their children on illegal alcohol and drug use in the following ways: parents should have serious discussions with their children regarding our policy on illegal alcohol and drug use and the possible consequences of violating the policy; they should discuss how other cities, states, and countries in which the students may travel with the school may have different laws and also may have different punishments than the region in which they live in the U.S.; and they should explain that students are expected to comply with all rules and act as adults with respect to the school's policy, since the school has no duty to act as their parents and cannot, and will not, monitor them.
